

NAVCORE Development End-User Software License Agreement

Software Usage License

By purchasing our software, you are purchasing a license for its usage only.

1. Usage Rights

Subject to the payment of applicable license fees and your compliance with this EULA, NAVCD grants you a non-exclusive, limited license to install and use the software within the scope of the License Types and on the permitted number of computers.

2. License Types

For all license types, you may install unlimited copies of the software.

a. Full License

You may apply and use an additional copy of the license on a second, portable device, laptop or home computer, exclusively by the same person only, without requiring an additional license.

b. Trial License

You are granted full use of the software for evaluation purposes only, for a period of 30 calendar days from the date the trial license was created. Upon expiration of the Trial Period, the license will revert to a limited, free license version, with limited functionality.

c. Free License

You are granted limited use of the software, with limited functionality.
